## Section C. Programme Profile Information (as supplied by provider)

<b>Brief synopsis of the programme</b>
<p>The Data Analytics (10 ECTS, Level 8) programme introduces learners to the fundamentals concepts of data analytics. Learners will identify Big Data problems and learn how to extract value from an organisation’s internal data. They will explore open data sources and utilise current technologies, tools and methodologies in the development of data solutions. Learners will understand how to interpret and manage data sets - acquiring knowledge of the key elements in planning, managing, and executing individual data analysis undertakings - and develop skills in the effective management of a portfolio of data analytics projects. These skills and abilities are central to a career as a trainee Data Analyst or to commence study in Data Analytics or Financial Technology (FinTech). Through this programme, learners will acquire knowledge and understanding relating to data analytics and develop industry-aligned skills to support them in future career ambitions.</p>
<b>Target learner groups</b>
<p>The Data Analytics micro-credential programme is targeted towards learners who wish to gain essential knowledge of data analytics. The programme is aimed at learners who wish to gain knowledge and understanding of data analytics and are considering upskilling or re-skilling in this area. It is anticipated that this programme may particularly appeal to individuals employed in non-computing related sectors who wish to develop their knowledge and skills in this area, or are considering a career in which foundational knowledge of data analytics would be useful.</p> <p>The minimum entry requirements for the Data Analytics micro-credential programme are:</p> <p>? A Level 8 primary undergraduate honours degree with a minimum Pass classification from a recognised third level institution in a non-cognate area.</p> <p>Or</p> <p>* A minimum Level 7 Ordinary Bachelor’s degree in a cognate area such as computer science, technology, networking, information systems, engineering, general science, mathematics, statistics, data science.</p> <p>Or</p> <p>* Applicants who do not have a Level 8 qualification and who have at least 3 years’ work experience may also be considered through the college’s normal RPL procedures. Relevant professional experience may be taken into account and individuals will be assessed on a case-by-case basis through DBS RPL procedures.</p> <p>Minimum language proficiency requirements</p> <p>* Applicants whose first language is not English and who have not previously undertaken a relevant qualification taught in English must provide evidence of proficiency in English language equivalent to B2+ or above on the Common European Framework of Reference for Languages (CEFR). This must be evidenced through a recognised English Language test such as IELTS, Cambridge Certificate or DBS English assessment. Test certificates should be dated within the last two years to be considered valid.</p> <p>Minimum maths proficiency requirements</p> <p>* Candidates will be required to have at minimum of Ordinary-Level Leaving Certificate mathematics, or be able to demonstrate competency at an equivalent level.</p>

4. *Clearly state what software will be used on this MCP to deliver the practical skills referenced frequently in the learning outcomes and evidence.*

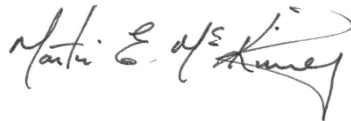
Each of these have been fully addressed to the satisfaction of the Panellists.
